ZSIS welcomes you to the next academic year; 2025-2026. If you wish to continue to be a member of ZSIS or wish to join us as a new member, we kindly request that you carefully read the agreement.

Registration Information

- 1. Registration for current and new students starts on 09.03.2025
- Seat Reservation Fee for New and Current Returning Students is non-refundable and non-transferable and is equal to 4,000
 SAR. It is part of the total annual fees and is deducted from the first installment.
- 3. The **Registration Fee** for new students is non-refundable and non-transferable and is equal to **1,500 SAR**. This is a one-time fee and is <u>not deductible</u> from the total annual fees.
- 4. The Entrance Exam/Assessment Fee is equal to 300 SAR for Kindergarten and 400 SAR for Grades 1 to 12. This amount is non-refundable and non-transferable and is to be paid again in case a retest was requested by parents.
- 5. Student acceptance priority is for siblings of current students in case of the availability of seats.
- 6. 15% VAT is to be added to the sum of the tuition fees to non-Saudi students.
- 7. Failure to complete payment before the stated deadlines will result in the deactivation of all the student's and parent's online accounts.
- 8. Tuition fees do not include the School Uniform and Book Packages.
- 9. Tuition fees are divided into two payments.

Registration Agreement Rules

- 1. I will read and sign the agreement upon submission for registration.
- 2. I will submit the Registration Application along with all the required documents and payment.
- 3. I will complete the payment of the current school year fee prior to submitting the application for the next academic year.
- 4. I acknowledge that the Registration Fee does not mean that my son/daughter will be allowed to attend classes. The first installment should be covered in full for students to start attending.
- 5. Current students will be removed off the school lists until the re-registration process is completed and the agreement is signed.
- 6. In case of student file withdrawal after the beginning of the academic year during a period of 15 days or less, I will be entitled to complete 25% of the total tuition fees.
- 7. In case of student file withdrawal after the beginning of the academic year during a period that exceeds 15 days and before the beginning of the 2nd Term, I will be entitled to complete 60% of the total tuition fees.
- 8. In case of student file withdrawal after the beginning of the second Term, I will be entitled to complete 85% of the total tuition fees.
- 9. In case of the student's failure to show up during the first two weeks of school without an official notice by the guardians or parents, the student's registration will be cancelled, and the fees are non-refundable.
- 10. In case of registration from the second school term, 60% of the total tuition fee is to be paid.
- 11. The Administration has the full right to retain the Student's File and Report Card in case of the failure to complete the fee installments as scheduled. Hereby, I do not have the right to request any access to the student's file before completing the full payment.
- 12. I will commit to the full payment of the yearly tuition fees based on the installments scheduled.
- 13. The current student will be removed from the school's lists for the academic year 2025-2026 until the re-registration process is completed and the agreement is signed.
